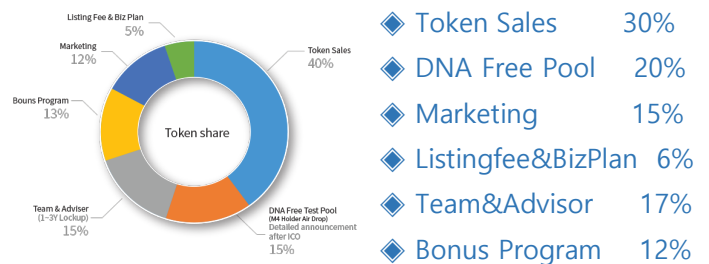
Medical 4th Chain

Medical 4th Chain recognizes the reality that countries and individuals can no longer afford to pay increased medical costs. In the end, all solutions are in the prevention of disease, and the key is to develop personalized prevention and treatment through free DNA testing.

It is an incidental goal to distribute practically useful Dapp and Medical A.I. by processing DNA and Medical Data accumulated in Medical 4th Chain.

Business model

1. Money Pool (HP (Health Point, exchangeable to M4th with points within the platform) with free DNA testing with TGE funds
2. M4th Distribution of HP within Platform for DNA testing to holders of certain conditions
3. Once HP is distributed, the data is donated after free DNA testing at the specified DNA testing laboratory.
4. Formulate DNA data for sale to global pharmaceutical companies
5. The proceeds sold back to HP Pool and the rest distributed to the DNA data provider
6. Free DNA testing HP provided to M4th holders
